Dear Mr Stilianos,

You will be advised when Letters of Administration with the will annexed are granted to Public Trustee. It is not proposed to provide you with copies of the Application, or other documentation, leading to Letters of Administration being granted.

With respect to the third paragraph of your email, there have obviously been legal costs incurred prior to the estate being referred to this Office. Clause 3 (a) of your late mother's will states..."to pay all my just debts funeral and testamentary expenses and all estate succession and other death duties payable in respect of any of the gifts devises or bequests under this my Will".

It is considered that legal costs may come within the category of "testamentary expenses", and therefore the estate may well have to pay these costs from funds held.
