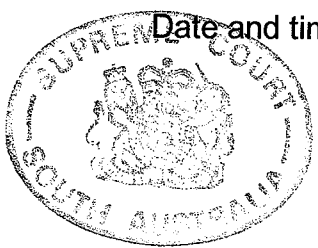

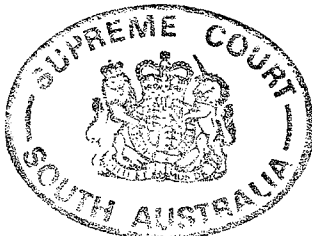
1. Advice and directions concerning the following:


As to what assets in Greece fall into and form part of the estate of Erini Stiliano deceased ("the deceased").



- 1.2. Directing the plaintiff as to what enquiries ought to be made to ascertain what assets in Greece form part of the estate of the deceased.
- 1.3. Directing what steps the executor must take to ascertain what assets in Greece form part of the estate of the deceased.
- 1.4. An order restraining the first defendant from taking any steps to deal with the following real properties situated in Greece, namely Certificates of Title 129, 189, 671, 683, 891, 2067, 2096, 2490, 2977, 3134, 4155, 4331 and 4378.
- 1.5. As to what persons should be served with notice of this application and the manner of such service.
- 1.6. A determination as to whether the debts and funeral and testamentary expenses of the deceased are payable out of:
 - 1.6.1. The residuary estate of the deceased.
 - 1.6.2. The proceeds of sale of the Australian house property.
 - 1.6.3. Any asset or assets of the deceased in Greece.
- 1.7. Leave to the plaintiff to pay out of the net proceeds of sale of the Australian house property all current and future debts and funeral testamentary expenses of the deceased upon such terms and conditions as the Court may think fit.
- 1.8. The costs of an incidental to this application to be paid out of the estate of the deceased.
- 1.9. Such other or further orders the Court may think fit.
